Assistive Technology Resources At A State Level

I. INTRODUCTION

As CMS grantees are continuing to identify strategies for successful nursing home transition to an array of community living options, there is an ongoing need to identify resources for support of assistive technology access and use. Each state has an AT project, which can assist you with questions about assistive technology and home use. The following brief report provides additional information about the AT Act and state contacts.

II. ASSISTIVE TECHNOLOGY ACT OF 1998

In 1998, Congress passed the Assistive Technology Act of 1998 (ATA), P.L. 105-394, which affirms that technology is a valuable tool that can be used to improve the lives of Americans with disabilities. An assistive technology device is defined by the ATA as "any item, piece of equipment, or product system, whether acquired commercially, modified, or customized, that is used to increase, maintain, or improve the functional capabilities of individuals with disabilities."

The ATA, the result of a bipartisan effort in Congress, extends the funding of the 50 states and six territories (America Samoa, District of Columbia, Guam, Northern Mariana Islands, Puerto Rico, and the U.S. Virgin Islands) that had received funding under the Technology-Related Assistance Act of 1988, as amended (Tech Act) to develop permanent, comprehensive, statewide programs of technology-related assistance. Under the ATA all states and territories are eligible to receive funding for 10 years. States that have completed 10 years in the program will have 3 additional years of federal funding to continue their assistive technology programs.

A. Title I

Under Title I in the new ATA, states and funded territories are required to conduct the following activities:

- Support a public awareness program designed to provide information related to the availability and benefits of assistive technology devices and assistive technology services.
- Promote interagency coordination that improves access to assistive technology devices and services for individuals of all ages with disabilities.
- Provide technical assistance and training including the development and implementation of laws, regulations, policies, practices, procedures, or organizational structures that promote access to assistive technology devices and services.
- Provide outreach support to statewide community-based organizations that provide assistive devices or services to individuals with disabilities or assist individuals in using assistive technology devices and services including focusing on individuals from underrepresented and rural populations.

The states and funded territories under the ATA have the option of performing several discretionary activities including providing alternative state-financed systems to increase access to and funding for assistive technology; providing demonstrations of assistive technology devices; offering options for securing assistive technology devices and services; and using various methods to provide technology-related information.

Individual legal advocacy for obtaining assistive technology through state protection and advocacy (P&A) agencies continues to be a provision of the new law. Under the ATA, state P&As will receive their funding directly from the National Institute on Disability and Rehabilitation Research (NIDRR), the administrating agency for the assistive technology programs.

B. RESNA Technical Assistance Project

The RESNA Technical Assistance Project (http://www.resna.org/taproject/) is funded by the Tech Act of 1988, as amended. The technical assistance project provides consultation, training, and information to states to aid in their efforts to provide access to and funding for assistive technology for individuals with disabilities. Under the ATA, technical assistance continues. One of the technical assistance activities will establish a national public internet site to provide information regarding assistive technology and other disability-related resources.

C. Title II - National Activities

The ATA also includes Title II - National Activities. National activities include coordination of federal research efforts; a report* by the National Council on Disability (http://www.ncd.gov) describing the barriers in federal assistive technology policy to increasing the availability of assistive technology devices and services for individuals with disabilities; and coordination with the Access Board (http://www.access-board.gov/) on Section 508 of the Rehabilitation Act of 1973, as amended. Other national activities include (1) small business incentives, (2) technology and universal design, (3) universal design in the built environment, (4) outreach, (5) training pertaining to rehabilitation engineers and technicians, and (6) programs by the President's Committee on Employment of People with Disabilities. *(Report: Federal Policy Barriers to Assistive Technology, May 31, 2000,

D. Title III - Alternative Funding Mechanisms

Title III authorizes alternative funding mechanisms for assistive technology that may include a low-interest loan fund, an interest buy-down program, a revolving loan fund, or a loan guarantee or insurance program. III. STATES FUNDED UNDER ATA

There are fifty-six state assistive technology programs, one in every state, commonwealth and territory of the United States. The 56 state and territory programs are funded under the Assistive Technology Act of 1998. State Assistive Technology projects have developed statewide programs that work to reduce or eliminate barriers that impede access to and funding for assistive technology devices and services for individuals with disabilities of all ages. The projects focus their efforts on changing systems, such as

education, vocational rehabilitation, medical assistance and others that deliver services to individuals with disabilities.
